2.)Installation/Display/Dismantling: Dates and hours for installation can be obtained by calling 608-297-3166. We ask that you are set up and ready each day at the start time.

3.)Liability: Vendors must insure their property. The vendor agrees to make no claim for any reason whatsoever against the Care & Share Food Bank of Marquette County or Lake Arrowhead Campground; nor another contractor for loss, theft, damage, or destruction of goods nor for any injury to self or employees; nor any action of any nature of the Care & Share Food Bank of Marquette County or Lake Arrowhead Campground, committees, employees or subcontractors.

4.)Fire, Safety, and Health: The Exhibitor agrees to accept full responsibility for compliance with local, city, and state inspection guidelines for Fire, Safety, and Health ordinances regarding the installation and operation of equipment.

5.)Exhibitor Responsibility: Exhibitor agrees to indemnify the Care & Share Food Bank of Marquette County or Lake Arrowhead Campground against and hold it harmless for any claims arising out of the acts of negligence of vendor, their agents, or employees.
